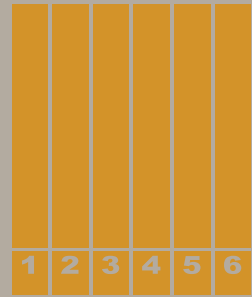
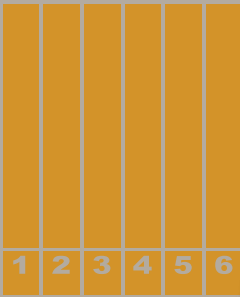

CAMP SHAWNEE is a weeklong overnight camp during the months of June and July. Camp begins Monday morning and ends on Friday afternoon, with the exception of the week of the 4th of July and the Day Camps.

WE BELIEVE each child is a unique individual with their own special talents and strengths. We seek to provide activities that allow all children to learn new skills and to experience success.

We seek to provide all activities in a safe manner and:

- Have trained lifeguards on staff
- Require children to wear life jackets anytime they are near the lake. In the swimming pool, life jackets are worn unless the camper passes a swimming test.
- Provide training to all camp staff and volunteers
- Have medical personnel on staff

TO APPLY: Camp Shawnee staff will be accepting registrations for camp during April and May. You may call Camp Shawnee or contact your Family Resource Center for applications. Camp Shawnee **MUST** receive your application 2 weeks (14 days) prior to the camp session your child is planning to attend. You will receive a confirmation email once we have received your completed application. There will be a \$20.00 registration fee per camper, which is non-refundable. You can also register online this year at christianapp.com/campshawnee.

TRANSPORTATION: Your transportation information, including the drop-off/pick-up site will be listed in your confirmation email. You must provide an email address on your application. If you do not have an email address, please contact us at **606.874.2091** or **606.789.9791** after submitting your application to receive your confirmation and transportation information.

WHAT TO BRING AND WHAT NOT TO BRING

Clothing (Old) As Follows:

Shorts, Shirts, Socks, and Underwear for each day. One-Piece Bathing Suit or Trunks, 2 pr. Gym Shoes, Sweatshirt, Raincoat, Pajamas, (Please mark the clothes as campers have a tendency to leave them at camp)

Personal Hygiene Items:

Toothbrush, Toothpaste, Hair Brush, Soap, Wash Cloths, Towels, Shampoo, Deodorant, Needed Medications**

**To be in original containers only!

Campers **SHOULD NOT** Bring:

Money, Food, Jewelry, Tobacco, Weapons, Personal Electronics (iPod, Video Game Systems, Cell Phones, etc.)

Children are not allowed to use the phone, but parents may call and speak to a staff person if they are concerned about how their child is doing.
